

HELLO, LATVIA / SVEIKA, DZIMTENE! TERMS AND CONDITIONS OF PARTICIPATION 2023

1. I, the participant, agree to pay full fees and costs associated with the "Hello, Latvia!" / "Sveika, dzimtene!" program to ALA by the Payment Deadline.

Trip Fees: \$3,000.00

Includes accomodation - double occupancy either with a family member or other group participant^{*}, ground transportation in Latvia, 3 meals a day, and all admission fees and tour guides.

*Single-room occupancy, where available, for supplementary fee of \$500.00.

Participants are responsible for their own international travel arrangements and requested to meet group in Rīga on designated date at specific time and place.

Deposit: \$500.00

APPLICATION DEADLINE February 28, 2023

Until Application Deadline trip fees are 100% refundable (not including ALA membership fees)

March 1 – March 31, 2023.

- Trip fees are refundable, LESS membership fees & \$100.00 of deposit.

April 1 – May 31, 2023

- Trip fees will be refunded, LESS membership fees and entire \$500.00 deposit, to cover prepaid and unrecoverable trip expenses for ALA.
- PAYMENT DUE IN FULL June 1, 2023
 After June 1, 2023 trip fees are not refundable.

Should ALA cancel the trip at any point in time, all trip fees minus ALA membership fees will be refunded to the participant.

- 2. I, the participant, understand that ALA has a general policy of non-discrimination and agree to refrain from any discriminatory behavior of other participants while participating in ALA programs.
- 3. I, the participant, will sign a medical release form authorizing emergency medical treatment, if or and when deemed necessary by the group leader and/or consulting physician and will not hold ALA responsible for any actions relating to the emergency treatment. I agree that I am responsible for all medical expenses incurred during the trip including the cost of medical evacuation from Latvia. It is my responsibility to obtain adequate travel medical insurance to cover these and

other unnamed contingencies or to cover these costs myself. I will provide medical insurance information to the organizers.

- 4. I, the undersigned, represent to ALA that the risks attendant to this trip have been explained to me by representatives of ALA, acknowledge that the trip has been arranged for the benefit of the participants as a service to its members by ALA, and hereby waive any and all claims against ALA, its agents or employees, whether arising within or without the United States, for any loss, damage, or injury whatever to persons or property, to include personal injury to the participant, arising out of or connected in any way with my participation in the "Hello, Latvia!"/"Sveika, dzimtene!" program.
- 5. I understand that I am responsible for any damage I may cause while on tour to hotel property or other facilities and agree to pay for any such damage without delay.
